# REQUIREMENTS ON CARRIAGE OF PUBLICATIONS (Circular NMC4.2015 (rev1))

### PURPOSE:

The purpose of this Marine Circular is to provide guidance to all ship owners / ship managers / ship operators / ROs on the carriage of publications.

### **RELATED DOCUMENTS:**

IMO MSC-MEPC.2/Circ.2 – IMO Requirements on Carriage of Publications On Board Ships, 01 June 2006

### APPLICATION:

This marine circular applies to all commercial Niue flagged vessels, except for Section C which applies specifically for vessels equipped with a ship radio station.

### CONTENTS:

## A. RECOMMENDED PUBLICATIONS

The SOLAS, MARPOL, LOAD LINES, COLREG and STCW Conventions deal with many operational aspects, navigational responsibilities, safety-related training/drills on board, safe cargo handling, oil spill prevention, collision avoidance activities and watchkeeping standards. Thus, the Niue Ship Registry (NSR) recommends that the publications of these Conventions be carried on board even though not expressly required by IMO instruments.

The publications recommended by NSR to be carried on board ships are listed in the table below:

The required documents/publications to be carried on board ships required by SOLAS Chap IV to be equipped with Ship Radio Stations are listed in the table below:

## D. GENERAL REQUIREMENTS AND ELECTRONIC EQUIVALENTS

- 1. The above listed publications may be in electronic format in lieu of hard copies except where the publications are for emergency use (refer to Section D.9 below).
- 2. All publications should be the latest editions/revisions and up to date.
- 3. Electronic publications should be those issued by the IMO, the Niue Ship Registry, or a body authorized by the Niue Ship Registry.
- 4. Nautical charts and nautical publications, such as Sailing Directions, Lists of Lights, Notices to Mariners, tide and current tables, and all other nautical publications necessary for the intended voyage, should be adequate and up to date.
- 5. Electronic nautical publications should be distributed directly by a Hydrographic Office or through a service approved by a Hydrographic Office.
- 6. Where electronic publications with backup are used, the portions required for navigation when the vessel is enroute should still be printed and included with the voyage plan unless the electronic backup is an independent computer system with its own emergency source of power. The same applies to the ITU publications found in Section C above.
- 7. The media (CD-ROM, Flash drive etc.) containing the electronic publications should be treated in accordance with the document control procedures in the ships' Safety Management System (SMS) which should also include procedures for timely update.
- 8. A nonconformity should be filed by an ISM auditor when a vessel fails to carry the required publications. However, no deficiency should be filed by Port State Control officers when vessels are found not to be carrying the publications recommended by NSR.
- 9. Notwithstanding the above, publications for emergency use, such as the IAMSAR Manual should always be available in the form of hard copies.
